## **Duties of the County Attorney**

The County Attorney and the Assistant County Attorney are the chief law enforcement officials of the county. *Iowa County Attorneys Association Prosecutorial Standard 1.1(A)*. The County Attorney and the Assistant County Attorneys shall represent the case of the people as to both civil and criminal jurisdiction. The criminal representation shall be the primary responsibility.

The civil jurisdiction of the County Attorney shall be as specifically required by state law. *Iowa County Attorneys Association Prosecutorial Standard 1.1(B)*. This civil jurisdiction required by state law includes the following duties (including citations to the Iowa Code):

- Appear for the state and the county in all cases in which the state or the county is a party. 331.756(2)
- Enforce all forfeited bonds and recognizances and prosecute all proceedings necessary for the recovery of debts, revenues, moneys, fines, penalties, restitution of court-appointed attorney fees ordered pursuant to section 815.9, including the expense of a public defender, and forfeitures accruing to the state, the county or a road district in the county, and all suits in the county against public service corporations which are brought in the name of the state. 331.756(5)(a)
- Commence, prosecute, and defend all actions and proceedings in which a county officer, in the officer's official capacity, or the county is interested or a party. 331.756(6)
- Give advice or a written opinion, without compensation, to the board and other county officers and to township officers, when requested by an officer, upon any matters in which the state, county, or township is interested, or relating to the duty of the officer in any matters in which the state, county, or township may have an interest, but the county attorney shall not appear before the board at a hearing in which the state or county is not interested. 331.756(7)
- Give a receipt to all persons from whom the county attorney receives money in an official capacity and file a duplicate receipt with the county auditor. 331.756(9)
- Make reports relating to the duties and the administration of the county attorney's office to the governor when requested by the governor. 331.756(10)
- Appoint a member of the civil service commission for deputy sheriffs. 341A.2 & 341A.3
- Represent the civil service commission for deputy sheriffs in civil suits initiated by the commission for the proper enforcement of the civil service law. 341A.16
